In addition to this information, in order to ensure that your data is processed as correctly and transparently as possible, you must be aware that:

- > The data communicated will be stored until your request for cancellation (art. 17 EU Reg. no. 2016/679) the Data Controller will delete the personal data of the data subject without undue delay if: the personal data are no longer necessary with respect to the purposes for which they were collected or processed; the data subject withdraws consent; the data subject objects to the processing and there is no overriding legitimate reason for proceeding with the processing; the personal data have been unlawfully processed.
 - In any case, your data will be kept for as long as necessary so that it can be fulfilled for tax purposes provided for by law or any other regulatory source;
- You have the right to ask the Data Controller for access (art. 15 EU Reg. no. 2016/679) to your personal data and rectification (art. 16 EU Reg. no. 2016/679), the erasure of the same, the limitation of processing (art. 18 EU Reg. no. 2016/679) concerning you or to object to their processing (art. 21 EU Reg. no. 2016/679); portability (art. 20 EU Reg. no. 2016/679): understood as the right to obtain data from the Data Controller in a structured format of common use and readable by an automatic device in order to transmit them to another data controller without hindrance
- In the processing whose legal basis is indicated as: provision of consent by the data subject, you may withdraw your consent at any time without prejudice to the lawfulness of the previous processing; Personal data processed for additional optional purposes (marketing purposes) will be deleted after the term of 2 years, a term considered appropriate since they are data related to the sale of the goods/services covered by the contract and in any case will be deleted upon withdrawal of consent, without prejudice to the lawfulness of processing based on consent before revocation.
- You have the right to lodge a complaint with the following Supervisory Authority (art. 51 EU Reg. no. 2016/679: Guarantor for the protection of personal data;
- In the processing whose legal basis is indicated as: compliance with a legal obligation or the execution of a contract to which the data subject is a party, the communication of your personal data is necessary to process your request, therefore in the event of failure to communicate such data we will not be able to proceed with the activities envisaged by it;
- Your data will not be subject to any automated decision-making.
